- 2. Vendors are not allowed to sell Fall Festival t-shirts, hats, etc.
- 3. 220 Electric spots are limited. 110 are more readily available, but also slightly limited. Booths with electricity will pay an additional \$75
- 4. Spaces will be available for setting up table booths at 3pm on Friday, Oct 25<sup>th</sup>. A security person will be on duty from 9pm Friday night to 6am Saturday morning, at which time chamber board members will then be around. Food trucks must be set up by 1PM on Friday in designated area, and will not be allowed to set up on Saturday unless prior authorized by the Chamber.
- 5. We will assign booths when application is received and paid. The earlier the application and payment are received the better the spot we can allot to you. Please have application in by October 23<sup>rd</sup>
- 6. Vendors will be mapped out first around Courthouse Square, and down Main Street. Spaces will be limited with electricity, therefore, only vendors that need electricity will be in Courthouse Square, Main Street, and other areas where electricity is available.
- 7. If you wish to only participate in one day of the festival, the fee will not change. This is so that we may reserve your space.

- 8. Vendors must list items that are being sold on this application.
- 9. ALL Vendors that will have a generator will be placed away from Courthouse Square, and Main St. NO EXCEPTIONS.
- 10. Vehicles are not allowed in festival area or throughout festival where streets are shut down during festival hours. This is a safety precaution due to extra foot traffic throughout the festival. Set up time is determined by road closures.
- 11. Vendors are not allowed to sell the following items for booths or food trucks: cotton candy, popcorn, caramel and candy apples, corn dogs, funnel cakes and sno-cones.
